Chair Linda Penner welcomed the Board Members and public to the November 12, 2015 Board of State and Community Corrections (BSCC) meeting.

Ms. Penner introduced new Board Member Bobby Haase, Director (A) of Adult Parole Operations, California Department of Corrections and Rehabilitation Mr. Hasse replaced Daniel Stone, who had retired as Director of the APO, CDCR. Ms. Penner administered the oath of office to Mr. Haase.

Ms. Penner announced that legal counsel Kara Ueda of Best & Krieger was present.

### IV. CONSENT ITEMS:

Ms. Penner requested that Agenda Item E, the conditional awards recommendations for the SB 863 jail construction funding, be heard first after the Consent Calendar.

Mr. Dean moved that Agenda Item E be heard first in the discussion items. Mr. Ertola seconded. The motion carried.

- C. Assembly Bill 900 Phase II (Local Jail Construction Financing Program) Siskiyou County Time Extension: Requesting Approval.

This agenda item requested that the Board of State and Community Corrections approve staff's recommendation to extend Siskiyou County's AB 900 Phase II jail construction project establishment schedule from November 13, 2015 to February 2016.

Ms. Penner asked if anyone would like any items from the Consent Calendar, Items A – C be placed on the discussion agenda.

There were no Public Comments.

Ms. Perez moved to approve items A, B, and C. Mr. Dean seconded. The motion carried.

### V. DISCUSSION AGENDA ITEMS:

D: Request for Appointment of Co-Chairs of the Proposition 47 Executive Steering Committee: Requesting Approval.

This agenda item requested the Board appoint Co-Chairs for the Proposition 47 Executive Steering Committee (ESC).

Staff recommended the Board:

- 1. Appoint Co-Chairs for the Proposition 47 Executive Steering Committee;
- Direct staff to post information about this ESC on the BSCC website and request statements of interest from individuals who would like to participate on the ESC; and
- 3. Direct staff to work with the Co-Chairs to develop proposed ESC membership and then seek Board approval of the ESC at a future Board meeting.

Ms. Penner nominated Board Members Leticia Perez and Scott Budnick as Co-Chairs of the Proposition 47 Executive Steering Committee. Ms. Perez and Mr. Budnick accepted.

Public comments were heard.

Mr. Dean moved to appoint the Board of State and Community Corrections' (BSCC) Board Members Leticia Perez and Scott Budnick as Co-Chairs for the Proposition 47 Executive Steering Committee (ESC); to have staff post information about the ESC on the BSCC's website and request statements of interest from individuals who would like to participate on the ESC; and for staff to work with the Co-Chairs to develop a proposed ESC membership for the Board's approval at a future Board meeting. Statements of interest would be accepted through February 29, 2016. Mr. Bejarano seconded. The motion carried.

# E: Senate Bill 863 (Adult Local Criminal Justice Facilities Construction Financing Program): Executive Steering Committee's Funding Recommendations: Requesting Approval.

This agenda item requested approval of conditional award recommendations totaling \$500,000,000 submitted by the Senate Bill (SB) 863 Local Adult Criminal Justice Facilities Construction Funding Executive Steering Committee (ESC).

Deputy Director Magi Work stated that the BSCC had received questions about the process for appealing a decision of the Board. Ms. Work indicated that the Regulations on Appeals had been provided to the Board, and that copies were available and could be found on the meeting materials table in the room.

Counties wishing to submit an appeal had 30 days to do so after receiving notice of the BSCC's action. Should there be any appeals submitted, the BSCC would hear appeals prior to the February 4, 2016 meeting.

Because Ventura County had applied for funding, Mr. Dean recused himself and was not present during the vote or discussion.

Staff recommended the Board approve:

- The proposed conditional awards; six small counties, five medium counties, and four large counties that ranked highest on the list established by the Senate Bill 863 Jail Construction Financing Program ESC; and
- 2. Should a county revert its conditional award back to the State that staff would be allowed to offer the funds to the next-ranked county within the same population category.

Public Comments were heard.

Mr. Budnick had concerns as to Butte County's ability to acquire its proposed matching funds. It was determined that Butte County be given the opportunity to find, if legal, an alternative source of funds without using the Inmate Welfare Fund.

Mr. Budnick moved to approve the conditional awards, as recommended by the Executive Steering Committee, conditioned on a determination of the legality of Butte County's proposed matching funds and if legal, encourage the county to find an alternative source of funds. Mr. Steinhart seconded. The motion carried.

**F:** Presentation of the Standards and Training for Corrections Annual Report: **Information Only.** 

This agenda item provided the annual report for the Standards and Training for Corrections (STC) Division for Fiscal Year 2014/2015 including compliance findings.

There were no public comments. No action was taken by the Board.
