It would prioritize projects that combine mental health services, substance use treatment services, housing, job skills and other community supportive services. The bill would require the BSCC to establish an Executive Steering Committee to include specified expertise. It would increase the membership of a regional juvenile justice commission and require a juvenile justice commission and a probation commission to inspect any jail, lockup, or facility used for solitary confinement for more than 24 hours and provide its report and recommendations to the BSCC and the county Board of Supervisors and to publish and post its report. It would require each Community Corrections Partnership, by June 1, 2015, to report to the BSCC on the county's capacity to collect and report data and its plan for consistently collecting specific information. It would appropriate an undetermined sum to the BSCC for purposes of funding the grants. It would require counties to report specified data to BSCC by January 1, 2016, and annually thereafter. It would require the BSCC to report to the Legislature by June 15, 2015, the estimated need, cost, and schedule for each county to collect and report data as required.
