**JUVENILE PROBATION CAMP FUNDING – CAMP FUNDING PORTION**

Beginning in fiscal year (FY) 2014-15, the State Controller's Office (SCO) began, on a monthly basis, allocating funds deposited in the Enhancing Law Enforcement Activities Subaccount (Welfare and Institutions Code §18220.1[c]) among counties that operate juvenile camps and ranches based on the average daily population (ADP) of occupied beds in each camp as reported to the Board of State and Community Corrections (BSCC) in the previous fiscal year. For FY2018-19, each county's allocation will be based on the ADP from FY2017-18. The SCO will continue monthly electronic funds disbursement to all participating counties based on the annual allocation percentage as determined by the Department of Finance (DOF) (see enclosed allocation letter, dated September 11, 2018). The BSCC will continue to collect monthly information on the number of occupied beds and rated capacity (RC) of local camps/ranches. The Monthly Camp Population Report is enclosed for your use and should be submitted to the BSCC by the 10<sup>th</sup> of the following month. Once the counts are received, the BSCC will calculate the county's ADP and forward the breakdown of ADP percentage to the DOF. The DOF will use this data in determining each county's percentage of allocation to be used for the following FY.

To ensure that participating counties' annual allocation percentages are computed accurately, the BSCC requires that each county submits an annual Camp Eligibility Form, which has been enclosed for your completion. The name(s) and RC of your county's eligible juvenile camp(s)/ranch(s) have already been filled in for your convenience. Before submitting your form, please be sure to complete all required areas and verify both your county's participation and the listed facility(ies) information. As we require an original signature, your completed Camp Eligibility Form should be returned to us via mail to the address above (attention "FSO Report Analyst") **no later than January 29, 2019.**
