Project Title	The Organized Retail Theft Prevention Grant Program
Proposal Summary	The Santa Clara County Office of the Sheriff (SCCSO) is submitting a proposal for combatting organized retail theft (ORT), vehicle theft, and vehicle accessory theft under this Grant Program. Silicon Valley is located in the County and is the epicenter of technology advancement and innovation. It has a population of almost 2 million residents and has an increasing number of retailers to support the demand. SCCSO has responded to countless incidents of ORT and prides itself in providing exceptional community service and has aggressively investigated all thefts, commercial burglaries and organized retail theft rings that plague the local businesses and retailers.

**Project Need** 

**Demonstration of Need and Scale of Crime Problem:** 

California Penal Code 490.4 was codified into law to address organized retail theft from a crime standpoint in 2019. Between 2019-2022, deputies responded to and investigated 73 incidences of organized retail theft in Sheriff's Office jurisdictions with the most frequently hit retailers being Apple Inc., Target, and Ulta Beauty. Similarly, vehicle theft and vehicle accessory theft has been as rampant as ever. Over that same time period, 2019-2022, deputies investigated 3,684 vehicle thefts and 551 catalytic converter thefts. These statistics only represent those in Sheriff's Office jurisdiction, which includes unincorporated areas of the County as well as the contract cities of Cupertino, Saratoga and Los Altos Hills. These statistics do not include the other municipalities in the County.

Prior to the nationwide law enforcement staffing crisis, the Santa Clara County Office of the Sheriff was able to support a small burglary suppression team that would proactively and covertly target offenders such as organized retail theft rings as well as commercial and residential burglars; However, budget cuts and staffing shortages forced that unit to be dissolved. The evidence suggests there is an opportunity for impactful and proactive responses to ORT, vehicle theft, and vehicle accessory theft with additional support from this grant opportunity. Moreover, the current intelligence and statistics suggests that this ORT and vehicle theft trend is only increasing in Santa Clara County.

**Project Description** 

**Proposed Grant Fund Usage and Collaboration:** 

In reimagining strategies to prevent and enforce ORT and vehicle theft, the Santa Clara County Office of the Sheriff recognizes the department's response to this community issue needs to have a multifaceted approach rather than simply reactive investigations. Should the Santa Clara County Office of the Sheriff receive funding as part of this grant program, a robust four-pronged approach will be initiated that would include crime deterrence, directed enforcement, and community education and collaboration components. This program would be referred to as the Sheriff's Coordinated ORT Reduction and Enforcement (S.C.O.R.E.) project and provides the ability to dedicate resources to solely focus on the prevention and enforcement of organized retail, vehicle, and vehicle accessory theft. This inception of this program will facilitate expedited prosecutions, better chances at evidence recovery, quicker restitution for retailers, and a safer community for residents, patrons, employees and businesses.

The first prong to this innovative response is a dedicated marked patrol unit assigned solely to be a visible law enforcement presence in retail stores, strip malls and shopping centers within Sheriff's Office jurisdiction and serving as a liaison with those business. This strategy would greatly improve the ability to deter crime through a uniformed presence in our retail and shopping districts. Current patrol resources do not allow for dedicated units assigned to these areas and current patrol responses for service at local businesses are primarily handled by beat units based on call priority.

The second prong is to augment personnel to prioritize these criminal investigations by adding investigators and supervision dedicated to this mission. Instead of relying on general property crime detectives with high

caseloads and conflicting priorities, the Santa Clara County Office of the Sheriff will launch a specialized unit solely responsible for the investigation and apprehension of those engaged in ORT, vehicle theft and vehicle accessory theft. A focused area of responsibility has proven to be fruitful in other specialized units within the Santa Clara County Office of the Sheriff as it provides a defined direction and scope of mission. This unit would be responsible for follow-up investigation of any applicable crimes to include leveraging technology, intelligence gathering, and using legal process to collect requisite evidence and apprehend the perpetrators.

The third prong is strengthening community partnerships and providing outreach to our local retailers, corporations, chambers of commerce, and retail or commercial real estate owners. The Santa Clara County Office of the Sheriff plans to allocate staff to provide proactive community outreach to raise awareness about resources, tips and best practices to our local retailers should they be confronted with organized theft rings. The benefits to providing a direct contact for retailers include the ability to report suspicious behavior before a crime is committed, quickly obtain evanescent digital evidence when a qualifying crime is committed and strengthen community partnerships with the goal of providing exceptional customer service, facilitate criminal prosecutions, and expedite the return merchandise or restitution.

Lastly, the fourth prong to this approach is leveraging technology to investigate, arrest, and prosecute perpetrators, especially leading those leading these criminal enterprises. The Santa Clara County Office of the Sheriff requires advanced data operations, investigations, and analytics tools to have the ability to synthesize data quickly and accurately from a wide variety of sources within the department including CAD, RMS, digital evidence such as body worn camera footage, and other information. The Santa Clara County Office of the Sheriff also needs the ability to easily share information and collaborate in real-time with the county prosecutor and neighboring law enforcement agencies as individuals and groups engaged in ORT often operate regionally. Santa Clara County Office of the Sheriff analysts need modern technologies to proactively identify trends and patterns in ORT activity to better inform early intervention and prevention strategies.

## **Essential Equipment:**

The Santa Clara County Office of the Sheriff will utilize this grant funding to procure and field a modern data integration, analysis, and collaboration platform. The Santa Clara County Office of the Sheriff seeks a unified software platform from which the department can run its coordinated strategic response to ORT and vehicle related theft. This type of platform will enable all of the below roles within the Santa Clara County Office of the Sheriff to better utilize data in efforts to prevent and enforce this criminal activity:

\* Patrol and dispatch will have real-time, streamlined access to vital information regarding involved people, premises, and vehicles, as disparate and siloed systems are integrated into a single platform that is also available on all mobile devices. Given how quickly these operations can move to commit these large-scale thefts and fence the stolen items, delays in retrieving vital information from disparate systems are extremely costly.

- \* Investigations will be able to develop leads quicker as data is integrated and connected automatically. ORT crews operate within networks and repeat offenders are common. A unified platform will help identify connections between individuals and groups through universal search, geospatial analysis, and network analysis that will lead to cases being closed quicker and with greater confidence.
- \* Analysts will be able to spend less time gathering, cleaning, and linking data and more time on valuable analysis that can inform counter-ORT strategies. As the Santa Clara County Office of the Sheriff implements ORT prevention and intervention strategies, criminals will adjust. Analysts will then be able to quickly customize and modify reports and analytical products within a unified platform to adjust rapidly to changes in criminal activity.
- \* Command Staff will be able to measure the results of decisions and strategies enacted, and pivot to put scarce resources toward the most impact approaches. The reporting functions within a unified platform will give them the information they need at their fingertips to make these difficult decisions in a data-driven manner.
- \* Interagency coordination and collaboration will be enabled and accelerated. The Santa Clara County Office of the Sheriff needs a single platform to share data with partner agencies, collaborate on investigations, and plan targeted enforcement in real-time. This will be especially important in sharing all evidence gathered with the District Attorney's Office foe successful prosecution as well inter-agency collaboration and intelligence sharing to solve cases spanning multiple jurisdictions. Through joint collaboration with the District Attorney's, the crime analysts within the Crime Strategies Unit can be leveraged to support the investigative efforts through data and analytics.

Furthermore, a unified platform will provide Santa Clara County Office of the Sheriff a flexible foundation that can be used to understand and combat other criminal activities that impact commercial enterprise and economic activity. The platform will form a digital backbone that will allow Santa Clara County Office of the Sheriff to successfully enforce ORT and other high priority crimes today and align our technology investments with the departments long-term strategy and vision for improving quality of life for Santa Clara County's citizens.

A small portion of these funds will be used to purchase vehicles as the investigators assigned to the specialized ORT unit will need undercover police vehicles to conduct surveillance and facilitate other investigative techniques to aggressively pursue violators. Lastly, the Santa Clara County Office of the Sheriff will need to upgrade some of the information technology infostructure to support unified software platform.

## **Likelihood of Achieving Intended Objectives:**

First, the Santa Clara County Office of the Sheriff points to the California Highway Patrol's (CHP) Organized Retail Crime Task Force (ORCTF) established in 2019. The ORCTF has been successful in deterring, arresting and successfully prosecuting criminals involved in organized retail theft through increased visibility and inter-agency collaboration to make arrests and recover stolen merchandise. Since the inception of ORCTF, the CHP reports the arrest of 645 suspects and the recovery of over 271,000 items of stolen retail merchandise valued at around \$26 million. The strategy employed by CHP suggests the concept of

dedicated investigative personnel coupled with increased visibility in retail locations positively impacts retail theft. Many jurisdictions, including the Santa Clara County Office of the Sheriff, are often reliant on grant programs or other funding streams to support specialty units for directed enforcement.

Moreover, the Santa Clara County Office of the Sheriff participates in and is the administrator for the Santa Clara County Regional Auto Theft Task Force (RATTF). RATTF has membership from 7 other law enforcement agencies with the sole purpose of impacting auto theft in the county. In Fiscal Year 2020, RATTF recovered 563 vehicles with an approximate value of \$6,253,967. In Fiscal Year 2021, RATTF recovered 529 vehicles with an approximate value of \$7,962,300. In Fiscal Year 2022, RATTF recovered 409 vehicles with an approximate value of \$6,490,900. RATTF is another example of how dedicated staffing can impact priority crime problems with focused efforts and directed enforcement. RATTF has been prolific at combatting vehicle theft in Santa Clara County, but there is still room for improvement if the Sheriff's Office was able to supplement staffing efforts related to auto theft investigations. Despite the presence of RATTF, there is a significant void in the follow up of vehicle accessory theft investigations. It is the position of the Santa Clara County Office of the Sheriff that the initiatives outlined in this proposal have the ability to be successful with funding to supplement staffing and equipment needs.

Capacity and Coordination

Project Organizational The Santa Clara County Office of the Sheriff is fully committed to impacting ORT, vehicle theft, and vehicle accessory theft in Sheriff's Office jurisdictions and collaborating with other law enforcement agencies as the perpetrators do not recognize jurisdictional boundaries. The Office of the Sheriff has the ability to staff the requested positions solely for the intent and purpose of the grant should funding be approved. Additionally, the Office of the Sheriff has great working relationships with the District Attorney's Office and the 13 other law enforcement agencies in Santa Clara County. The Office of the Sheriff is committed to a collective and collaborative effort to combat ORT as demonstrated by the attached letters of commitment by the District Attorney's Office and the Santa Clara County Police Chief's Association. The Office of the Sheriff will host quarterly meetings specifically aimed at coordination of enforcement efforts, intel sharing, and investigative updates related to ORT, vehicle theft, and vehicle accessory theft.

> Furthermore, the Office of the Sheriff plans to approach the Santa Clara County Board of Supervisors for a continued funding commitment for personnel costs after the program is initiated and statistics justify the need for the unit through the number of arrests and merchandise recoveries. The Office of the Sheriff plans continued financial support of the unified software platform even after the grant performance period as the value of the software has the ability to extend to all investigatory functions of the office. In short, the Office of the Sheriff will be in position to capitalize on county funding after the grant funding expires if the statistics support the efforts that are anticipated.

Project Evaluation and Monitoring

**Evaluation of the Grant:** 

The overall effectiveness of the Santa Clara County Office of the Sheriff initiatives under this grant program will be demonstrated through the following measurable metrics and objectives: 1) a tangible decrease in ORT, vehicle theft, and vehicle accessory theft cases reported year over year through deterrence and enforcement efforts; 2) an increase in criminal prosecutions by the District Attorney's Office for qualifying crimes; and 3) an increase in stolen merchandise recovery and a marked decrease in the total loss to retailers impacted by ORT in Santa Clara County jurisdiction.

**Grant Monitoring and Measurable Objectives:** 

The Sheriff's Office tracked ORT cases since CA Penal Code section 490.4 was codified in 2019, The Sheriff's Office also has historically tracked vehicle and vehicle accessory theft cases. Quantitative analysis will be conducted to evaluate and measure the overall effectiveness of the SCORE project for the grant performance period. The data will be directly compared to previous years' data to determine the effectiveness of the efforts and where to shift or allocate resources to increase effectiveness, if necessary. Additionally, analysis will be conducted to evaluate and measure the quality and quantity of qualifying crime investigations based on the number of offenders, the charges filed, and number of convictions. The data collected for qualifying crime investigations under the SCORE project during the grant performance period will be directly compared to previous years' data to determine the effectiveness of the efforts. Lastly, SCORE will work with retailers and businesses victimized by ORT and compare financial loss statements attributed to ORT theft year over year to include historical comparison. The data will provide good insight into the effectiveness of SCORE project and how the positive impact of this initiative.



## **POLICY**

The Sheriff's Office is committed to providing services and enforcing laws in a professional, non-discriminatory, impartial, and equitable manner that keeps both the community and deputies safe and protected. The intent of this policy is to increase the Sheriff's Office effectiveness as a law enforcement agency and to build mutual trust and respect with the diverse groups and communities of Santa Clara County.

It is the policy of the Sheriff's Office to provide law enforcement services and to enforce the law equally, fairly, objectively, and without discrimination toward any individual or group. The Sheriff's Office expressly prohibits racial and identity profiling (Pen. Code § 13519.4).

All employees of the Sheriff's Office are prohibited from taking law enforcement actions, including the use of force, based on actual or perceived personal characteristics, including but not limited to race, color, ethnicity, national origin, age, religion, political affiliation, gender identity or expression, sexual orientation, mental and or physical disability. All employees of the Sheriff's Office shall rely on their training and experience when engaging in the investigation of appropriate suspect specific activity to identify a particular person or group. Personnel must not delay or deny policing services based on an individual's actual or perceived personally identifying characteristics. All employees should draw upon their training and use their critical decision-making skills to assess whether there is criminal conduct and to be aware of personal implicit bias and bias by proxy when carrying out their duties.

## BIAS-BASED POLICING PROHIBITED

Bias-based policing is strictly prohibited. However, nothing in this policy is intended to prohibit a deputy from considering protected characteristics in combination with credible, timely and distinct

information connecting a person or people of a specific characteristic to a specific unlawful incident, or to specific unlawful incidents, specific criminal patterns or specific schemes.

## A. <u>DEFINITIONS</u>

Racial or Identity Profiling: The consideration of, or reliance on, to any degree, actual or perceived race, color, ethnicity, national origin, age, religion, political affiliation, gender identity or expression, sexual orientation, or mental or physical disability in deciding which persons to subject to a stop or in deciding upon the scope or substance of law enforcement activities following a stop, except that an officer may consider or rely on characteristics listed in a specific suspect description. The activities include, but are not limited to, traffic or pedestrian stops, or actions during a stop, such as asking questions, frisks, consensual and nonconsensual searches of a person or any property, seizing any property, removing vehicle occupants during a traffic stop, issuing a citation, and making an arrest.

<u>Bias-Based Policing:</u> conduct by peace officers motivated, implicitly or explicitly, by the deputy's beliefs about someone based on the person's actual or perceived personal characteristics, i.e., race, color, ethnicity, national origin, age, religion, gender identity or expression, sexual orientation, or mental or physical disability.

<u>Explicit Bias:</u> Conscious belief or attitude toward a specific social group or person that may lead an individual to act in discriminatory ways.

<u>Implicit Bias:</u> the attitudes or stereotypes that affect a person's understanding, actions, and decisions in an unconscious manner. These biases, which encompass both favorable and unfavorable assessments, are activated involuntarily and without an individual's awareness or intentional control. Implicit biases are different from known biases that individuals may choose to conceal.

<u>Bias by Proxy:</u> when an individual calls/contacts the police and makes false or ill-informed claims of misconduct about persons they dislike or are biased against based on explicit racial and identity profiling or implicit bias. When the police act on a request for service based in unlawful bias, they risk perpetuating the caller's bias. Sworn and civilian staff should use their critical decision-making skills, drawing upon their training to assess whether there is criminal conduct.

## B. CALIFORNIA RELIGIOUS FREEDOM ACT

Employees shall not collect information from a person based on religious belief, practice, affiliation, national origin, or ethnicity unless permitted under state or federal law (Government Code § 8310.3).

Employees shall also not assist federal government authorities (Government Code § 8310.3):

1. In compiling personal information about a person's religious belief, practice, affiliation, national origin, or ethnicity.

2. By investigating, enforcing, or assisting with the investigation or enforcement of any requirement that a person register with the federal government based on religious belief, practice, or affiliation, or national origin or ethnicity.

## C. THE RACIAL AND IDENTITY PROFILING ACT (RIPA) / STOP DATA

Unless an exception applies under 11 CCR 999.227, a deputy conducting a stop of a person shall collect the data elements required by 11 CCR 999.226 for every person stopped and prepare a stop data report.

When multiple deputies conduct a stop, the deputy with the highest level of engagement with the person shall collect the data elements and prepare the report (11 CCR 999.227). If multiple agencies are involved in a stop and the Sheriff's Office is the primary agency, the Sheriff's Office deputy shall collect the data elements and prepare the stop data report (11 CCR 999.227).

The stop data report should be completed by the end of the deputy's shift or as soon as practicable. It must; however, be submitted within 24 hours of the stop (11 CCR 999.227).

## D. <u>EMPLOYEE RESPONSIBILITIES</u>

Every employee of the Sheriff's Office shall perform his/her duties in a fair, impartial, and objective manner, and is responsible for promptly reporting any suspected or known instances of bias-based policing to a supervisor. Employees should, when reasonable to do so, intervene to prevent any biased-based actions by another employee of the Sheriff's Office.

## E. TRAINING

Training on fair and objective policing and review of this policy shall be conducted by the Training and Compliance Unit and supplemented with periodic roll-call training and discussions facilitated by supervisors.

- 1. All sworn personnel will be scheduled to attend Peace Officer Standards and Training (POST) approved training about bias-based policing, implicit bias, and bias by proxy.
- 2. Each sworn member of this department who received initial bias-based policing training will thereafter be required to complete an approved refresher course every five years, or sooner if deemed necessary, to keep current with changing racial, identity and cultural trends (Penal Code § 13519.4(i)).

## F. REPORTING TO CALIFORNIA DEPARTMENT OF JUSTICE

The Lieutenant of the Professional Compliance Unit or his/her designee shall ensure that all data required by the California Department of Justice (DOJ) regarding complaints of racial bias against officers is collected and provided to the DOJ as required for reporting (Penal Code § 13012; Penal Code § 13020).

Employees shall ensure that stop data reports are provided for required annual reporting to DOJ (Government Code § 12525.5). The Sheriff's Office Records Divisions shall be responsible for releasing the annual data to the DOJ consistent with existing record release procedures.

## Santa Clara County Office of the Sheriff Automated License Plate Reader (ALPR) Technology

## Annual Surveillance Report for September 1, 2021 - June 30, 2022

### 1. DESCRIPTION OF HOW TECHNOLOGY WAS USED

Automated license plate readers (ALPRs) use high speed cameras to photograph vehicle license plates. The Sheriff's mobile ALPRs are PIPS ALPR Technology and during this reporting period were placed on only one law enforcement vehicle and that placement was for authorized law enforcement and public safety purposes as set forth in the Surveillance Use Policy. The ALPR was used to collect license plate and vehicle information from vehicles on roadways, on property accessible to the public, or on private property when such license plates came in view of the patrol vehicle's cameras.

### 2. DATA SHARING WITH OUTSIDE ENTITIES

Consistent with the Board-approved Surveillance Use Policy, the Sheriff's Office ALPR data was shared with law enforcement organizations that are members of the South Bay Information Sharing System Group (SBISS), subject to log-in/password protection requirements and subject to the SBISS ALPR Policies and Procedures. ALPR data was also shared with the Northern California Regional Intelligence Center (NCRIC) and subject to their use policy. Consistent with Board Policy and the Board-approved Surveillance Use Policy, the Sheriff's Office does not share its ALPR data with U.S. Immigration and Customs Enforcement and did not do so during this reporting period.

Privacy concerns continue to remain a high priority with the use of this system and controls are in place to ensure that the data is only used and shared pursuant to legitimate law enforcement and public safety needs. As an example, we conduct frequent audits reviewing case numbers associated to searches to ensure the search was in fact pursuant to a specific crime. Also, any outside agency who requests a search of our system must provide their case number and crime type before the search is conducted. On-going training on the use of this system is provided to staff to ensure privacy concerns remain a continued best practice and use is in compliance with the Board policy.

### 3. COMMUNITY COMPLAINTS OR CONCERNS

Any community complaints regarding the use of the ALPRs are routed to Internal Affairs for tracking and response.

During the period for this annual report, there were no community complaints or concerns expressed to the Office of the Sheriff regarding the Mobile Automated License Plate Reader (ALPR) Technology.

## 4. NON-PRIVILEGED INTERNAL AUDITS / POLICY VIOLATIONS

All Sheriff's Office staff are provided all Surveillance Use Polices via an internal web-based portal requiring review and a completed attestation of acknowledgement. Internal audits were conducted, and no misconduct or misuse of the equipment or Surveillance Use Policy violations were discovered. The audits spanned information received by the Automated License Plate Reader Technology from September 1, 2021, through June 30, 2022.

## 5. EFFECTIVENESS IN ACHIEVING ITS IDENTIFIED PURPOSE

The identified purposes of the ALPR Technology is to alert law enforcement of stolen vehicles and plates, and to assist in locating vehicles involved in Amber Alerts, missing persons, hot pursuits, and those individuals associated to crime. The technology is also used to protect critical infrastructure as well as participants at special high-profile events.

Between September 1, 2021, and June 30, 2022, the Mobile ALPR system was down for technical maintenance and non-operational for 49 days. While operational, the system captured a total of 16,438 license plate images. Of those images captured, three license plate images were identified as fitting within the stated criteria; however, all three were misreads.

While this technology has produced valuable public safety results in past years, this year due to the down time of the vehicle and the system hardware there were no noteworthy cases to highlight. It is anticipated that the continued use of this technology in addition to future expansion of fixed mounted cameras will greatly enhance public safety and the Office's ability to prevent and solve crime in the community.

Section 7 of this Report outlines costs, which were paid using grant funding. This technology captures information such as the vehicle make, type, color, license plate as well as unique features of the vehicle such as bumper stickers or roof racks. The system does not check the state registration database for the registered owner and it does not capture images of the driver or passengers within the vehicle. Deputies respond to investigate the circumstances of the notification having no knowledge of the driver's gender, race, or ethnicity and by virtue of the manner in which the notification is made, this technology is not used disproportionately affecting lower-income community members or community members of color.

Based on the cost-benefit analysis and deliverables produced by this technology as outlined above, we believe the benefit to overall public safety currently outweighs the cost of this equipment. Due to the increasing trends of how this technology has solved criminal cases within Santa Clara County, it is anticipated the longer this technology is in place the frequency of success will continue to increase.

## 6. PUBLIC RECORDS REQUESTS

The Sheriff's Office has a process in place to track Public Records Act requests, with designated staff to receive and respond to each request. The Sheriff's Office did not receive any public records requests regarding this equipment, or images/data captured by the Mobile Automated License Plate Readers.

## 7. ANNUAL COSTS

The maintenance cost incurred by SBISS for the Back Office Software Server (BOSS) was \$6,252 which was paid for using SHSGP grant funding. Future funding for the BOSS will be funded with SHSGP and/or UASI grant funds.
