| SUBJECT: | ult Reentry Grant Program Appointment of Chair and Establishment of ecutive Steering Committee: Requesting Approval | | |

Summary

This agenda item requests approval to establish an Executive Steering Committee (ESC) to oversee the development of a Request for Proposals (RFP) for the Adult Reentry Grant Program. Staff is also requesting that the Board establish an ESC and designate a Chair to oversee the grant development process; authorize staff to work with the ESC Chair to establish a diverse ESC with relevant subject-matter expertise, including but not limited to that required in statute; and delegate authority to the Chair to modify ESC membership if needed.

Background

The Budget Act of 2018 (Senate Bill 840, Chapter 29, Statute of 2018) established the Adult Reentry Grant Program and appropriated \$50,000,000 in funding.

Pursuant to SB 840, the Board of State and Community Corrections is required to award competitive grants to community-based organizations to support offenders formerly incarcerated in state prison. The BSCC is required to form an ESC with members from relevant state agencies and departments with expertise in public health, housing, workforce development, and effective rehabilitative treatment for adult offenders to develop grant-program criteria and make recommendations to the board regarding grant award decisions. Representatives are to include but are not limited to the:

- Department of Housing and Community Development;
- Office of Health Equity;
- County Probation;
- Representatives of reentry-focused community-based organizations;
- Criminal justice impacted individuals; and
- Representatives of housing-focused community-based organizations.

As is always included in the ESC process, there will be opportunities for stakeholder and public input into the development of the Adult Reentry grant program throughout the process. Upon the Board's approval of this agenda item, staff will post information about this ESC on the BSCC website

stakeholders and subject matter experts who are interested in being considered as members of the Adult Reentry Grant ESC. Statements of interest may be submitted through August 17, 2018 from anyone who would like to serve on the ESC.

The Adult Reentry Grant Program funds (\$50,000,000) are to be allocated as follows:

- \$25,000,000 for rental assistance;
- \$15,000,000 for the rehabilitation of existing property or buildings for housing offenders released from prison;
- \$9,350,000 to support the "warm hand-off" and reentry of offenders transitioning from prison to communities;
- \$150,000 to support the Berkeley Underground Scholars Initiative; and
- \$500,000 to the BSCC for costs to administer the grant programs and report on program outcomes.

Funds appropriated in this item are available for encumbrance or expenditure until June 30, 2021.

Recommendation/Action Needed
