**RE: SAN JOAQUIN COUNTY ACCEPTANCE OF ADDITIONAL SB 1022
AWARD FUNDING AND REVISED PROJECT SCOPE**

Dear Mr. Villegas,

The County of San Joaquin is requesting to be the recipient of an additional \$4,183,286 of SB 1022 reverted funds to further add to our Detention and Program Facility if so awarded. This facility will provide the correct type of housing beds to accommodate a variety of classifications with a focus on treatment and rehabilitation. Reduction in recidivism is an outcome of the goal to prepare, educate, and train inmates before release.

The County initially requested from the State an award amount of \$40 million and was awarded a partial amount of \$32,328,000. After the funding was reduced, the BSCC approved a change in the project scope on June 8, 2017. This was done to ensure the successful completion of the project within the available funding.

The current approved project scope included 256 beds across four medium security level pods in dorm style two-tiered housing, each with a dayroom and access to a common outdoor recreation yard. The approved scope also included spaces for housing, programs, staff and administration, receiving and transportation, support, and a small medical clinic. Receiving and transportation will consist of food storage, a retherm kitchen, an inmate receiving area, and vehicle sally ports for inmate transport and food and laundry services.

With the additional funding, the County would like to request the approval of an addition to the project scope. Specifically, the County would like to attach a 12-bed mental health unit to the proposed Detention and Program Facility, enhancing facility needs for programs such as Jail Based Restoration to Competency Treatment (JBCT) and other mental health programs. The proposed mental health unit will also include a dayroom, interview room, programming space, and an outdoor recreation yard.

The County is confident we can successfully deliver a fully completed project at the level of the requested change, given the increase cost of materials labor, and the other escalation costs because of the modified funding timeline.

The County of San Joaquin would like to thank the Board of State Community Corrections for their support of our Project. We would like to thank you for your excellent support to the County during this process.

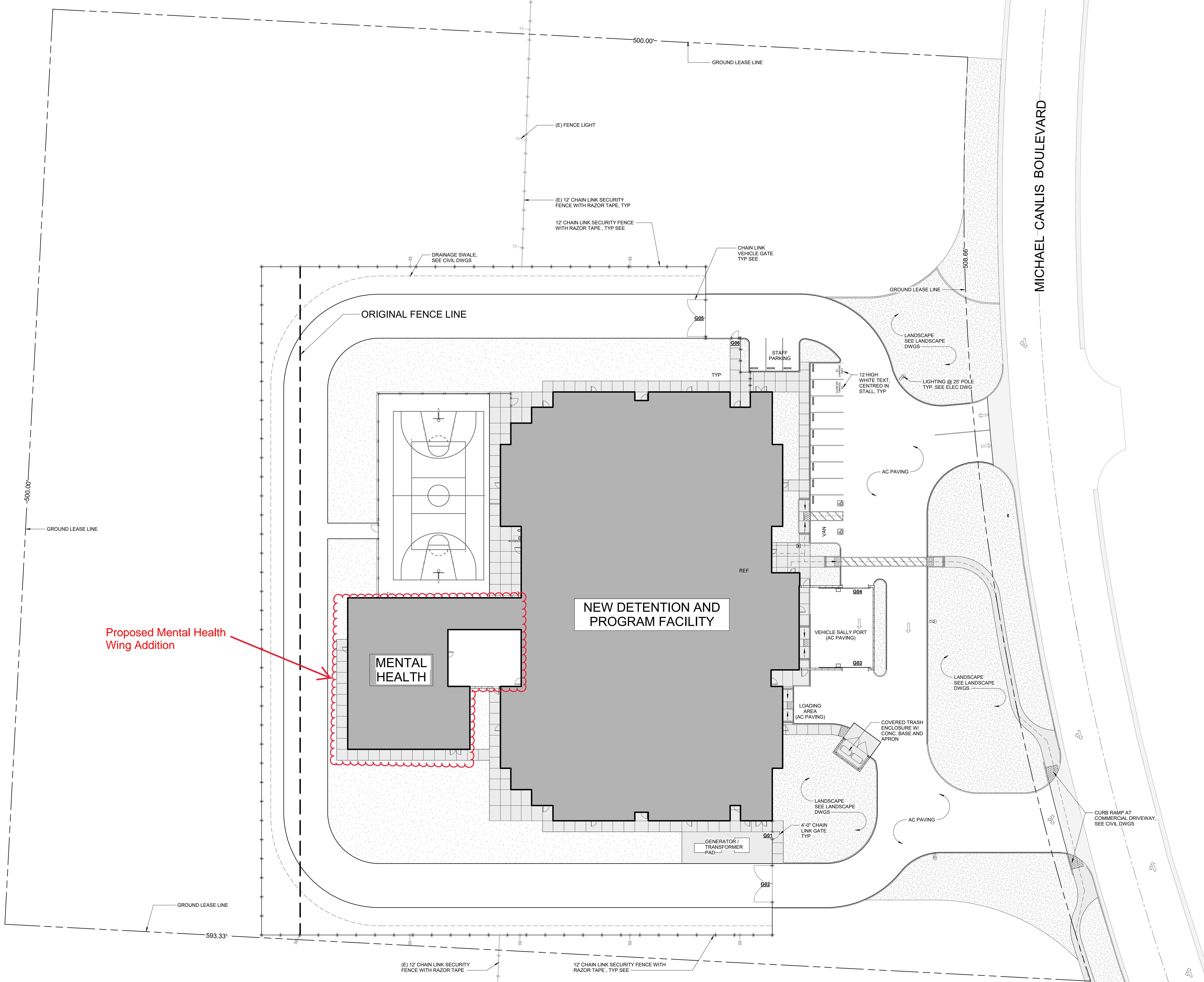
