

Prop 47 Grant Scoring and Funding Summary - June 2017

The 15 successful large-scope proposals are **highlighted in blue**; the eight successful small-scope proposals are **highlighted in yellow**. San Bernardino is recommended to receive partial funding.

Small-scope proposals, in purple, did not meet the scoring threshold and are not eligible to receive funding.
