


Population Estimates, 2012 – 2021








2020 Reported Crimes



Information reported in this section comes from the California Department of Justice's *Online Arrest Data 2008-2020* file (https://openjustice.doj.ca.gov/data), and also appears in the annual *Crime in California* publication (https://oag.ca.gov/cjsc/pubs).

Two important caveats to keep in mind:

- the number of arrests represent the number of arrests made, not the number of individuals arrested (a person can be arrested more than one time)
- the reported arrest offense is the most serious offense (the one with the most severe possible sanction).

Number of Arrests for Type of Offense, 2015 – 2020







Jails


This section presents information on the jail inmate population in:

The data in this section comes from the Board of State and Community Corrections *Jail Profile Survey – Online Querying* (https://app.bscc.ca.gov/joq//jps/QuerySelection.asp), and also appears in the quarterly *Jail Profile Survey* report (http://www.bscc.ca.gov/s fsojailprofilesurvey.php).

Average Daily Population of Jail Inmates, 2012 – 2021



² Sentenced inmates are individuals who have been tried and sentenced on all charges, and are awaiting transport to prison, or are serving some portion of their sentence in jail.
